- Confirmatief verzoek nr. 18/c/01/09				

In bijlage dezes gaat voor de delegaties een ontwerp-antwoord van de Raad, zoals dat luidt na de behandeling door de Groep voorlichting van 10 september 2009, op confirmatief verzoek nr. 18/c/01/09.

De Finse en de Zweedse delegatie gaven te kennen tegen het ontwerp-antwoord te zullen stemmen. De onderstaande verklaringen werden afgelegd:

- FI: "Finland kan instemmen met het ontwerp-antwoord wat betreft de openbaarmaking van de acht documenten. Met betrekking tot de overige 197 documenten kan Finland echter geen gefundeerd standpunt innemen, aangezien de nationale deskundigen geen concrete mogelijkheid hebben gehad om de documenten te bestuderen. Om die reden stemt Finland tegen het ontwerp-antwoord."
- SE: "Zweden stemt in met het ontwerp-antwoord wat betreft de verlening van gedeeltelijke toegang tot acht van de gevraagde documenten. Zweden heeft de overige documenten ter plaatse kort kunnen bestuderen. Op basis van dit onderzoek is Zweden van mening dat verdere gedeeltelijke toegang kan worden verleend. Zweden stemt derhalve tegen het ontwerp-antwoord."

Een meerderheid van de delegaties stemde in met de openbaarmaking van de uitslag van de stemming.

Het Comité van permanente vertegenwoordigers wordt derhalve verzocht de Raad in overweging te geven om tijdens zijn volgende zitting:

- het ontwerp-antwoord in de bijlage als A-punt goed te keuren, waarbij de Finse en de Zweedse delegatie zullen tegenstemmen;
- te besluiten de uitslag van de stemming openbaar te maken.

De bijlage bestaat alleen in het Engels.

REPLY ADOPTED BY THE COUNCIL ON TO CONFIRMATORY APPLICATION 18/c/01/09 made by fax on 27 June 2009, pursuant to Article 7(2) of Regulation (EC) No 1049/2001, for public access to documents

The Council has considered this confirmatory application under Regulation (EC) No 1049/2001 (OJ L 145 of 31.5.2001, p. 43) and Annex II to the Council's Rules of Procedure (Council Decision 2006/683/EC, Euratom - OJ L 285 of 16.10.2006, p. 47) and has come to the following conclusion:

- The applicant refers to reports by European Union monitors in Croatia, for the Knin area, from 1 to 31 August 1995 as well as the "ECMM RC Knin log reports".
- 2. In its reply dated 27 May 2009, the General Secretariat refused public access to the documents covered by the application pursuant to Article 4(1)(a), third indent, of the Regulation (protection of the public interest as regards international relations).
- In his confirmatory application lodged on 27 June 2009, the applicant challenges the General Secretariat's refusal to disclose the documents under scrutiny. Firstly, the applicant claims that there are no grounds for refusing public access to the requested documents based on the protection of international relations. In particular, he argues that:
 the reports by EU monitors for the Knin area at the time of Operation Storm, being EU documents, are necessarily impartial in nature, as the ECMM was not a party in the conflict;

- as the documents under scrutiny are now 14 years old, most infringements observed by EU monitors on the ground in August 1995 which would be revealed by publication of the documents would be time-barred; and

- the documents under scrutiny are not sensitive documents as referred to in Article 9 of Regulation No 1049/2001.

Secondly, the applicant disputes whether the Council is justified in relying on the exception relating to the protection of court proceedings in order to refuse access to the requested documents.

- 4. Owing to the very large number of documents concerned by the application and the complexity of the assessment incumbent upon the institution, the General Secretariat sent the applicant a letter on 2 July 2009, in accordance with Article 6(3) of the Regulation, seeking his understanding of the extension of the timeframe for replying the confirmatory application until 1 October 2009.
- 5. Having thoroughly examined the requested documents and carried out internal consultations with the General Secretariat, the Council has come to the conclusion set out below.
- 6. In its archives, the Council has identified 205 documents, listed in <u>Annex II</u>, as being covered by the applicant's first request, notably all reports by the EU monitors in Croatia in the Knin area between 1 and 31 August 1995. The Council could not identify any documents listed as "ECMM RC Knin log report", falling under the applicant's second request.
- 7. The primary objective of the European Community Monitoring Mission was to contribute to monitoring political and security developments in the Western Balkans as well as border monitoring, inter-ethnic issues and refugee returns. The documents covered by the application contain daily reports, special reports, topical reports and weekly assessments formulated by the EC monitors in the Knin region of Croatia between 1 and 31 August 1995. In particular, the requested documents contain information on
 - monitoring and analysis of troop and police movements and actions including shelling activities, breaches of ceasefires, shoot outs as well as other military matters including discussions with liaison officers and information provided by sources;
 - observations on freedom and restriction of movements;

- political monitoring including statements from high-level visiting officials, municipal officials, interviews with military and police actors, civil society actors;
- monitoring of human rights situation, such as abuses against the civilian population and their goods, evacuations, causalities, movements, refugee flows, refugee transportation;
- monitoring of construction or destruction of civilian infrastructure; and
- information on the impact of shellings or airstrikes.
- 8. The monitors carried out their activities in a particularly delicate political, military and human rights situation in Croatia. The monitors' reports contain comments, appreciations and analyses of the political, military and security situation in the Knin area. Many of those reports are based on interviews with local actors and witnesses, given on the basis of confidentiality. By reason of their nature and sensitive content, the reports were communicated solely to the headquarters and the local components of the Mission. Although the information contained in the documents was not classified at the time, their disclosure would still be disadvantageous to the interests of the European Union.
- 9. In fact, disclosure of the requested documents would put at risk the international relations of the EU and its Member States with the region, which continue to remain delicate, by releasing information revealing in detail comments, appreciations and analyses exchanged among the different components of the Mission of the political, military and security situation in the area. Disclosure of the contents of the reports would defeat the purpose of supplying the EU with the most detailed information before formulating a policy towards the Western Balkans. The Council considers that the confidentiality of the reports until today is an essential factor in enhancing dialogue and cooperation with the countries of the region.
- 10. Furthermore, disclosure of the documents in question would reveal the identity of the monitors and assessments formulated by them as well as that of the witnesses and other sources of information who were interviewed with the understanding of confidentiality. Under those conditions, disclosure of the requested documents would undermine the protection of public security and, in particular, the physical security and integrity of the monitors and that of the witnesses and other sources of information, who provided information with the understanding of confidentiality, by revealing to the public their identity and assessments contained in the reports.

- 11. The applicant disputes that the disclosure of the reports fourteen years after the occurrence of the events would undermine the protection of international relations. He argues that, on the contrary, the release of these documents, which are necessarily impartial in nature, may help establish the historical truth and victims' compensation for loss or damage suffered. In this regard, the Council would point out that pursuant to the first sentence of Article 4(7) of Regulation (EC) N° 1049/2001, the exceptions *"apply for the period during which protection is justified on the basis of the content of the document."* The Council takes the view that fourteen years after the drawing up of the documents in question, the reports retain an important degree of sensitivity, in view of the fact that they contain delicate information relating to a region where the consolidation of stability remains a main concern until today, and still need to be protected against disclosure.
- 12. Furthermore, the Council understands the applicant's interest in inspecting the documents for the purposes of establishing the historical truth by putting the war criminals on trial and obtaining compensation for the victims. However, it is necessary to point out that the Council may not take into consideration the applicant's particular interest in obtaining the documents, since it is called upon to rule, in conformity with Regulation (EC) N° 1049/2001 and Article 10(2) of Annex II of its Rules of Procedure, on the disclosure to the public of the requested documents, on an *erga omnes* basis.
- 13. The applicant also claims that disclosure should be possible, since the Council has already given access to the documents concerned to the parties in the Gotovina case before the International Criminal Tribunal for the former Yugoslavia (ICTY). In this regard, the Council would point out that a request by a member of the public under Regulation (EC) N° 1049/2001, such as the present application, may not be assimilated to a request made by an international judicial authority, such as the ICTY, in the framework of its legal proceedings. In the case invoked by the applicant, the Council made available the documents requested by the ICTY not on the basis of Regulation (EC) N° 1049/2001 but in accordance with the principle of international cooperation with an international tribunal established by the United Nations Security Council.

- 14. In his confirmatory application, the applicant calls into question the applicability of the exception relating to court proceedings and argues that an overriding public interest in disclosure exists. The Council would point out in this respect that the fact that the ECMM archives have been supplied to the parties to ongoing criminal proceedings before the ICTY was invoked by the General Secretariat in its initial reply in order to underpin the need for the protection of the requested documents under the third indent of Article 4(1)(a) of Regulation (EC) N° 1049/2001, notably the protection of international relations. The Council also notes that after having conducted consultations on the matter it does not invoke in the present reply the argument relating to the proper conduct of ongoing criminal proceedings.
- 15. In the light of the above, the Council concluded that, in accordance with the first and third indents of Article 4(1)(a) of Regulation (EC) N° 1049/2001 (the protection of public security and the protection of international relations), public access must be refused to the requested documents.
- 16. However, the Council took into consideration the possibility of a partial access to the documents on the basis of Article 4(6) of the Regulation. It concluded that public access may be granted to those parts of the following documents which are not covered by the above exceptions under the Regulation:

b) EUMM-#4124 - Daily report
c) EUMM-#4125 - Daily report
d) EUMM-#4132 - Daily report
e) EUMM-#4134 - Daily report
f) EUMM-#70968 - Daily report
g) EUMM-#71072 - Itinerary - HOM 28 and 29 AUG 1995
h) EUMM-#71076 - HOM/CAR 26 AUG 1995

The Council has also looked into the possibility of giving partial access to the remaining documents but it did not retain this possibility since partial access would amount to only small fragmentary parts which would be no use to the applicant.
