







Libyan women activists visiting the Netherlands in the week of the 19th to the 23rd of February 2018.

As part of the Dutch National Action plan, 4 Libyan activists (the main partners within the program) are visiting the Netherlands in the week of the 19th and 23rd of February. The purpose of their visit is amongst others to present the first findings of an action research implemented on the daily safety needs through the lens of women and youth lived realities. This research is based on their everyday experiences in Libya through a participatory approach. The activists would like to share their findings and recommendations with Dutch policy makers and civil society to support the development of meaningful engagement and interventions in Libya.

Profile of our Libyan guests

Hajer Sharief, appointed by United Nations Secretary General as member in the advisory group for the progress study on youth peace and security, mandated by the Security Council resolution 2250. She's also an advocate for the Kofi Annan foundation with the Extremely Together initiative on Countering Violent Extremism, most recently she has been chosen for the UN women's group of 'champions for women, peace & security and human rights'. In February 2017 she was awarded the student peace prize in Norway. Hajer is currently the project manager for the 'Together We Build it' organization which she co-founded during the war in Libya in 2011, and has been since working on supporting the democratic process in Libya by emphasizing the relevance role of women's and youth in peacebuilding, conflict resolution and preventing violent extremism.
