## Stakeholders for a Cohesive and Sustainable World

Today, we see the erosion of the international solidarity that forms the foundation of our global governance architecture. New multilateral initiatives or supranational bodies are unlikely to stem the decay. This geopolitical reality is the reason why communities and networks are forming to address pressing global concerns such as climate change, sustainable development and economic inclusion. Although interconnected, most operate independently of other stakeholders to the detriment of achieving an even greater collective impact. Increasingly absent is the political and societal cohesion that enables such collaboration.

There is a way forward to heal a divisive world but it requires a change in both mindset and behaviour. At the core of the World Economic Forum's DNA is the stakeholder concept: no institution or individual alone can address the economic environmental, social and technological challenges of a complex, interdependent world. - Sharing and promoting ideas, innovations and discoveries that will benefit societies globally
- Engaging those at the vanguard of change from such fields as the arts, media, medicine, science and technology, as well as the next generation of leaders

Urban environments provide complex health challenges for its inhabitants, many of which are magnified for those living in poverty. Research finds that 56 of the U.S.' 500 largest cities are home to people who can expect to live at least 20 fewer years than those in other neighbourhoods, even if they're just blocks or miles away. **How can health systems partner with other industries to sustainably build and finance interventions designed to address the social determinants of health in urban settings? Can these models be replicated across geographies?**

#### **Group 2: Integrating Social Determinants of Health to Advance UHC in Developing Nations:** [REDACTED] (confirmed)

Apollo's population based, holistic health program –“Total Health Program” (THP) operational in the Aragonda village of Chittoor District in Andhra Pradesh state of India, compliments the key UHC principles of – leaving no one behind, sustainable financing, monitoring for accountability and fostering multi-stakeholder partnerships by incorporating efforts to strengthen social determinants of health for achieving and sustaining these goals. **How can programmes, such as this, be replicated and scaled in other developing nations?**

## Achtergrondinformatie

### 1. Businessmodel.

WEF heeft berekend dat de coalitie een jaarlijks budget nodig heeft van [REDACTED]. De helft daarvan moet worden opgebracht door de zogenaamde value partners = de executive board leden. WEF rekent met een jaarlijkse bijdrage van [REDACTED]. Ze verwachten voor 2020 op deze manier [REDACTED] 'op te halen'. De EB telt op dit moment 13 leden. Ze houden er dus rekening mee dat niet ieder lid van de EB dit bedrag op tafel zal leggen.

Wij hebben in het vooroverleg laten weten dat het niet waarschijnlijk is dat wij [REDACTED] zullen gaan bijdragen. WEF maakt nu onderscheid tussen type A (private) en type B (publieke) EB-leden conform afspraken die we in 2019 al maakten. Publieke partners moeten anderszins hun waarde aangeven.

### 2. Specifieke projecten

A working team of [REDACTED] is following up on the action point from last year to develop an end-to-end informatics platform (as an enabler) for VBHC chronic disease management, starting with congestive heart failure. This platform comes with a model integrating the relevant data on patient pathways, process, costs and outcomes. The platform aims to provide insights and support population health decision making, and pathway optimization, at scale. The status of this work will be shared at the upcoming Board meeting in Davos.

- b. Your effort to 'seduce' projects in the Netherlands – like the [REDACTED] and the [REDACTED] - to share their lessons in the global coalition
- c. Your effort to 'recruit' a patient representative to play a role internationally to ensure that the patients voice is heard.
- d. Your availability to co-host a high level ministerial meeting, e.g. connected to the UN General Assembly, the World Health Assembly (Geneva) or the 2021 WEF meeting in Davos.





## Breakdown of annual membership fee by membership type


Membership fee in 2021 as an example

Expense forecast of GcfViHC



## SHIFT IN BUSINESS MODEL REQUIRES BRIDGE FUNDING OVER 3-5 YEARS

### 2 fundamental shifts in business model:

- Shifting away from donations-based model to a more self-sustaining business focused on machine readable sets and analytics

We anticipate the transition to a sustainable business model **will take [REDACTED] ~3-5 years.**

During this time period, we anticipate needing [REDACTED] in bridge funding to facilitate this evolution, and deliver an operational versioning model that can enable the global savings from VBHC




